## RESOLUTION OF APPRECIATION

WHEREAS, Stephen T. Davis was appointed to the Bay de Noc Community College Board on January 3, 2018; elected in 2018 and 2022 and served with dedication until February 28, 2025; and

WHEREAS, Stephen T. Davis supported Student Success, Community Success, and the Culture of Success at Bay de Noc Community College through his service in each office of the Board and Board Committees, and

WHEREAS, Stephen T. WHEREAS, Stephen T. Davis was committed to advocating for Student Success and dedicated to continuous learning opportunities by regularly attending Michigan Community College Association Summer Conferences for professional development and to develop collegial relationships with fellow trustees and peer schools; and

WHEREAS, Stephen T. Davis supported Community Success through his service as a trustee by supporting numerous construction projects including re-design of the Courtyard in 2018, installation of the Veteran's Memorial and expansion and renovation of the Physical Education Center in 2019, the \$2.8 million infrastructure improvements to the Escanaba campus in 2021; and championing the 50-year renewed lease partnership in 2021 to house the Northern Lights YMCA on the Escanaba campus; recognition of the College's Military Friendly School designation in 2021; and the College's Five Strategic Pillars adopted in 2024; and

WHEREAS, Stephen T. Davis supported the Employees of Bay de Noc Community College to create a Culture of Success through his service as a trustee by supporting the naming of Bay de Noc Community College as an Achieving the Dream Leader College of Distinction in 2019 and 2022 and the Achieving the Dream Special Recognition Award in 2020; and recognition as the 2022 Business of the Year from the Delta County Chamber of Commerce; and
